System Update on the Arkansas v5 Central Site

ESO updated the Arkansas v5 Central Site in mid-February this year. Here are some highlights:

- ◆ ICD-10-CM and ICD-10-PCS changes for FY 2024, effective October 1, 2023, have been incorporated.
- ◆ Tri-Code: ICD-10-CM assignments for pelvic open wounds, lacerations, and avulsions have been adjusted to assign codes from S31.0 - Open wound of lower back and pelvis.

Tri-Code vocabulary has been adjusted to understand S1, S2, S3, S4 and S5 as sacral spinal locations.

- ◆ Addition of new optional fields: SBIRT Results, Mental Health Screening Results, Mental Health Screening Intervention under ED/Resus/Labs/Screenings/Toxicology.
- ◆ Addition of new state required field of Transfer Rationale under Outcome/Initial Discharge to catch patients transferred out for organ procurement. Currently we are working with hospital, QSource, and Data Committee to get clarifications on how to enter patient data related to this field and catch all the death records. Once we reach an agreement, we will send a guideline out to hospitals.

ESO 2024 Annual Conference

We attended the ESO 2024 Wave April 1-5, 2024 in Austin, TX. We enjoyed exploring the new patient registry product, networking with trauma staff from Cox Health and other hospitals, learning from early adopters of the new product about their experiences during the transition, and gaining knowledge about the future for the trauma data management especially how AI will be applied to this field.

Trauma Registry Professional Day 2024

***** DATA SUBMISSION SCHEDULE *****

Data submittal will be based on discharges that occur in calendar quarters. The deadline for data submission is 60 days from the close of the quarter*. Arkansas Trauma Registry (ATR) recommends that data records be entered into the registry as close to the discharge date as possible. *Notify trauma registry staff and your ADH Trauma Nurse Coordinator by email if your submission will be late. Please include an estimate of when your submission will be completed.

January 1 through March 31
QTR 1 – May 31st

April 1 through June 30
QTR 2 – August 31st

July 1 through September 30
QTR 3 – November 30th

October 1 through December 31
QTR 4 – March 1st
