## Cancer PathChart

### Cancer Pathology Decoding Histology and Registration Terminology

Cancer Pathology Coding Histology And Registration Terminology (Cancer PathCHART) is a system for identifying tumor site, histology and behavior code combinations with associated terminology. An online resource will help ODS-C's use the same terms and coding standards. Cancer PathCHART is aligned with the Solid Tumor Manual (STM), Hematopoietic DB and other coding resources.

The CPC Site-Morphology Validation List provides:

1. Valid combinations, that can be entered
2. Impossible Combinations (cannot be entered)
3. Unlikely combinations (triggering site-type edits).

**QUICK TIP:** Melanoma biopsy procedures are often followed by a wide local excision. Code both procedures according to the type of biopsy performed, i.e.: shave, punch, etc. The 200 series codes are relative to the biopsy procedure, the 500 series codes capture the biopsy with the following WLE. Shave biopsy B220, shave biopsy with WLE B520

## RULES FOR ARKANSAS CANCER CASE REPORTING

In accordance with Arkansas cancer reporting law, all licensed health care facilities and providers are required to report cancer cases to the ACCR no later than six months after the date of diagnosis of cancer and/or initial treatment of cancer.

All cancer cases that were diagnosed or began initial treatment on or before **December 31, 2023**, should have been reported to ACCR. If you still have cases remaining from this period, report them immediately. Cases should be reported via WebPlus.

## SSDI: Consult results

\*Record consult over original results.



## SSDI: Recording Ranges

\*Code the next highest number based on lower value.



## SSDI: 'Greater than', 'Less Than', 'At least'

\*May refer to whole # or decimal  
Code the next highest number based on lower value.  
PSA stated as <8, record as 7.9.  
ER Percent Positive >76%, record as 077.

## SSDI BREAST: ER & PR Percent Positive or Range

\*Actual percent described, takes priority over range codes

See available table for results stated as ranges for applicable R code

\*If range is less than or equal to 10, code the appropriate R code based on the lower number:  
26-33%, code to R30 (21-30%)

\*If range is greater than 10, code to unknown (XX9):  
53-97%, code XX9

## TEXT: Primary Site & Histology

\*Required to be entered



## Diagnostic Confirmation:

\*Melanoma with biopsy or excision for tissue with pathologic exam:  
Code = 1

## COLLECTING DEMOGRAPHIC INFORMATION

### FIRST, MIDDLE, LAST NAME

- Never leave blank
- Enter UNKNOWN

### SOCIAL SECURITY #

- Must be 9 digits
- Can be partially filled with 9's
- Do NOT leave blank

### COUNTY AT DX

- Code 998 when known town, city, state or country, but county is not known
- Use ZIP CODE LOOK UP to look up zip for city, state if not known

### PRIMARY PAYER AT DX

- Code 1st insurance mentioned when multiple
- Code insurance closest to date of diagnosis
- Do not change after diagnosis
- Prisoners = Code 10
