Reporting Animal Prescriptions (for Pharmacists)

A Brief Review of Reporting:

In Arkansas, controlled substance dispensations by retail pharmacies must be reported no later than <u>next business day.</u> All dispensations submitted must pass through the PMP Clearinghouse before being uploaded to the Arkansas PDMP. Dispensations can be reported via several routes: via Secure File Transfer Protocol (often used by pharmacies), via a Universal Claim Form (UCF) (often used by veterinarians), or via a Web Portal Upload. Regardless of the method/route of reporting dispensations, the information will be routed to its assigned field on the Arkansas PDMP.

If a pharmacy does not dispense controlled substances, zero reports are required or the pharmacy may apply for an exemption waiver.

Per the Rules Pertaining to the Arkansas Prescription Drug Monitoring Program:

"If the prescription dispensed is for an animal patient, the prescription shall be reported as follows:

- (1) The prescription shall be identified as an animal/veterinary patient;
- (2) The owner of the animal/veterinary patient shall be reported to the department by first name, last name, and date of birth
- (3) The animal/veterinary patient shall be reported.

Implementing This Rule at the Retail Pharmacy – a Scenario:

A prescription comes to the pharmacy for an animal patient named Bear. The owner's name is Jane Doe and the owner's date of birth is 6/7/1980.

- Identify the prescription as an animal/veterinary patient. The process by which a prescription is identified as for an animal patient, will be different depending on the pharmacy vendor. See vendor instructions for ASAP format.
- 2. Report the owner's last name: "Doe."
- 3. Report the owner's first name: "Jane."
- 4. Report the owner's date of birth. Jane's date of birth is 6/7/1980.
- 5. And finally, report the name of the animal: "Bear."

Running a Patient Query:

When the pharmacist runs a patient query for an animal patient, they'll search by the following parameters: owner's first name, owner's last name, and owner's date of birth.

For a pharmacist, a history of dispensations for scheduled substances II-V will appear for both Jane and Bear (and any other pet that Jane is owner of): **BOTH owner and animal** dispensations will appear.
